

# **ABOUT US**

The Thurso Community Benefit Society (TCBS) is a young, ambitious organisation with big dreams for its team and those who live, work and visit Thurso. TCBS operates as the trading organisation for Thurso Community Development Trust and aims to generate profits from its activities, which are then reinvested in the community in line with the priorities of the Trust. We run several 'micro businesses' and have ambitions to develop the breadth and scale of our activities, generating profits and providing sustainable employment. We are careful to ensure that our plans do not compete with local businesses, but provide new opportunities. At present, TCBS main activity is to operate and develop Socially Growing, a social enterprise made up of two strands of activity;

# • THE SHOP

Socially Growing is a Zero Waste Refill Shop and Climate Hub in the centre of Thurso which has been operational since January 2021. It provides a variety of food, household and cleaning products.

# • THE GREENHOUSES

Our Greenhouses commercially grow locally produced Mediterranean style vegetables and plug plants. These are then sold in the shop and to local businesses. We now have our newly refurbished event space located at the greenhouses and will be running workshops along with hiring the space to the community.

Both areas offer volunteering opportunities to those looking to help in the community and gain valuable skills.

The essential criteria is a commitment to positively contributing to the development of our community, and to adhere to the principles of honesty, integrity, objectivity and accountability. We want our Board to represent the diversity of people in the area, so age, gender or your area of experience is no barrier to involvement. We often work online so we are able to consider applications from Caithness or further afield.

In addition to seeking people with the above skills, there is an open opportunity for a chairperson to join the team. This person, along with any new board members will be mentored and supported to allow for best results for the organization and the individual(s).

While our organisation needs a robust governance framework in place to guide its activities, being a member of the Board is not intended to be overly burdensome in either time or resource commitment.
