

Job Description - Support Worker

Purpose of the Post

The Support Worker will assist people living with dementia to achieve good outcomes using a range of therapeutic interventions, resources and activities as appropriate. Support is provided in a variety of settings and may also involve assisting access to resources in the wider community.

Accountability

Line manager will be either the Locality Leader, Practice Team Leader, Day Care Organiser or other post-holder, depending on local resourcing arrangements.

Main Duties and Responsibilities

The post holder will be expected to:

- 1 **Deliver a high standard of personalised and person centred support to people living with dementia,** working to achieve good outcomes for each person and following an agreed personal outcomes plan, where this is in place.
- 2 **Develop positive relationships with carers, family and friends**; and work in partnership with them, where appropriate, to identify the wishes and priorities of the person supported.
- **3** Use a range of therapeutic interventions, activities and resources to meet agreed outcomes for each person supported, adopting safe practice and following any actions set out in risk enablement plans.
- 4 **Monitor progress toward agreed outcomes for each person supported** and provide regular updates to the line manager using agreed reporting mechanisms.
- 5 Ensure up to date records are maintained in line with organisational standard and quality: assist in collating any relevant service records to meet required deadlines.
- 6 **Undertake relevant learning and professional development opportunities** to maintain and improve knowledge, skills and practice.
- 7 Attend meetings at local and / or national level, as required.
- 8 Undertake support at home, in day opportunities, Dementia Resource Centres and other locations on an occasional basis.



9 **Perform any other reasonable request** within the capability of the post holder.

All of the responsibilities and duties are to be carried out according to Alzheimer Scotland's standards, policies and procedures as described in the:

- Organisation's Manuals
- Practice Standards

Support Workers are expected to promote and adhere to:

- National Health and Social Care Standards
- Scottish Social Services Council Codes of Practice.

Salary - The post is graded at point 8

The post holder will require to be a member of the Protection of Vulnerable Groups Scheme.

This job description is open to review by the organisation at any time and was last revised in June 2021.
